



Notice of Public Hearing / Public Meetings

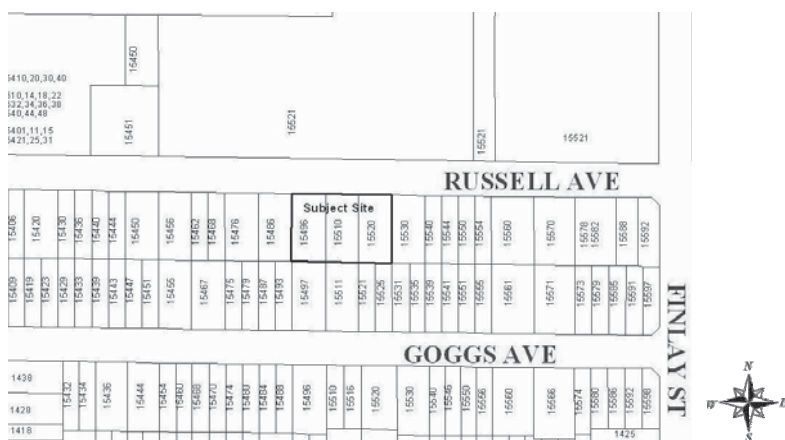
NOTICE is hereby given that the Council of the City of White Rock will hold a combined Public Hearing and Public Meeting in the City Hall COUNCIL CHAMBERS, 15322 Buena Vista Avenue, White Rock, BC, on **MONDAY, FEBRUARY 9, 2009 at 7:00 p.m.** under the provisions of the Local Government Act. At this Public Hearing / Meeting, all persons who believe their interest in the properties is affected by the proposed bylaw / applications shall be afforded an opportunity to be heard or to present written submissions respecting matters contained in the following bylaw / applications that are the subject of the hearing / meeting.

Bylaw 1861, White Rock Zoning Bylaw 1999, No. 1591, Amendment (CD-22 – 15496, 15510 and 15520 Russell Avenue) Bylaw, 2009, No. 1861

The purpose of this bylaw is to rezone 15496, 15510 and 15520 Russell Avenue (See Map 1) from One-Unit Residential Zone (RS-1) and Two-Unit Family Residential Zone (RT-1) to Comprehensive Development Zone (CD-22) to permit development of a 14 bed personal care (hospice) facility.

Development Variance Permit No. 302

The purpose of this Permit is to vary sections 402 and 403 of White Rock Zoning Bylaw, 1999, No. 1591, as amended, for 15496, 15510 and 15520 Russell Avenue, to permit an entry canopy at the front entrance to the complex to project 5.21m (17/1ft) into the front yard setback, and to reduce the minimum dimension requirements for an off-street loading space i.e. to reduce the minimum width requirement from 3.0m (9.84ft) to 2.8m (9.31ft), the height requirement from 4.2m (13.78ft) to 2.3m (7.5ft), and the length requirement from 7.5m (24.61ft) to 5.8m (19.0ft).
